- For animals six months old or less, use a blood card or a TSU.
- If sending in hair samples, make sure to pull (do not cut) hair from tail switch.
- Order DNA supplies through the American Aberdeen Association.
- Please completely fill out and use the Aberdeen DNA form.
- DNA testing takes CAN TAKE UP TO 3 MONTHS. Please plan accordingly.

**Herd Letters** - Each breeder has assigned herd letters upon joining the Association. Herd letters are a requirement in a tattoo. Please list your assigned herd letters in the designated box above. If you do not know your herd letters contact the Aberdeen Association.

**A Number** - Every Aberdeen animal must have an assigned number as part of the tattoo. Please assign your animal the designated number before filling out and submitting the DNA form.

**Year Letter** - Year letters in the tattoo designate what year the animal was born. Every Aberdeen animal must have a year letter as part of the tattoo. Year letter codes are as follows: 2023 - L, 2022 - K, 2021 - J, 2020 - H, 2019 - G, 2018 - F.
